Meet Our Speaker

Matthew Borowick has had a lifelong interest in the American Civil War, dating back to his days as a *first grader* when he took his copy of "The Golden Book of the Civil War" to school daily. In 1992 he joined the Robert E. Lee Civil War Round Table of Central New Jersey, serving as its newsletter editor, advisory board member and webmaster. Later, he helped establish the Civil War Library and Research Center and was its first Executive Director.



Today, Matt is a regular columnist for the well-regarded Civil War News, serving as the author of "Round Table Review", which describes best practices of Civil War round tables from throughout the country. In 2010, he authored and published The Civil War Round Table Handbook - The Indispensable Guide to Running Yours Right, which is available on Kindle at Amazon.com.

He serves as a volunteer at Manassas National Battlefield Park.

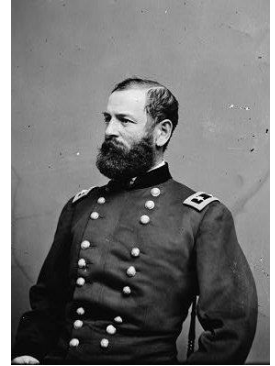

The Court Martial of Fitz John Porter

"Scapegoat": when we hear the word we think of a quarterback who couldn't complete a crucial pass to win the Super Bowl, a cleanup hitter who fans with two outs and the bases loaded in the seventh game of the World Series, or a seven foot center who misses a slam dunk and loses the NBA Championship.

As in sports, the Civil War had its share of heroes and its share of men to whom blame for defeat or disaster was attached. A Union defeat at Manassas in the summer of 1862 led to criticism and a court-martial for one of the rising stars of the Army of the Potomac's high command.

After Robert E. Lee drove John Pope's army back to Washington, questions were raised about who was responsible for the defeat. Fingers quickly pointed toward Major General Fitz John Porter, who did not perform as Pope had expected him to because, as Porter's enemies claimed, Porter wanted to see Pope fail. Porter spent the next 24 years of his life trying to clear his name. This unique and energetic presentation on a rarely-discussed but incredibly fascinating topic focuses on the events surrounding the Union defeat at Second Manassas and how rivalries in the Northern armies led to the downfall of one of the North's ablest generals.

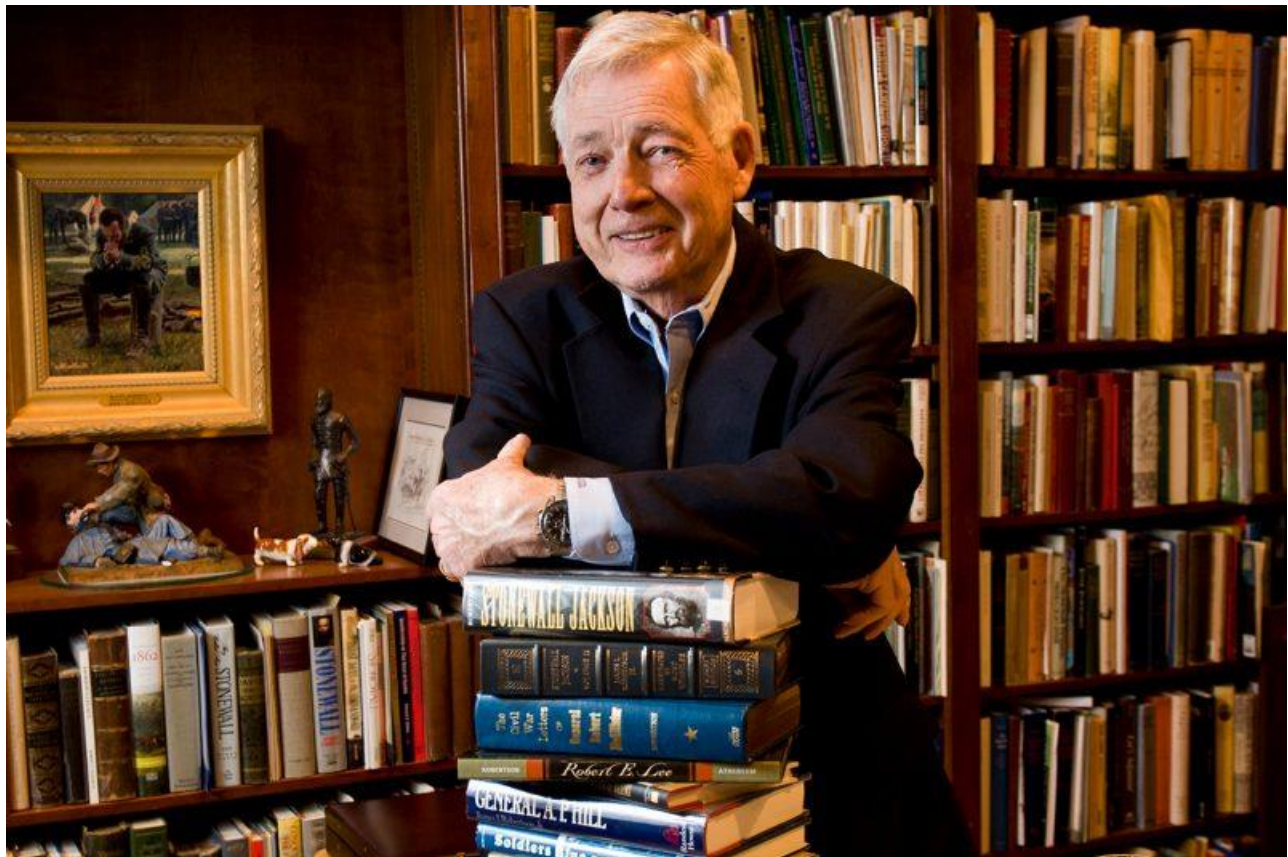

Dr. Richard Aud, Past-President, Passes Away

Dr. Richard E. Aud passed away on November 4. He was president of the Round Table in 1987-1988. Our condolences go out to his family and friends.



In Memoriam James I. "Bud" Robertson Jr.

James I. "Bud" Robertson Jr. lost his battle with cancer on November 2 and was laid to rest on November 16 in Westview Cemetery, Blacksburg, Virginia. His passing brought to a close a remarkable life and career that influenced thousands of students and tens of thousands of those who have an interest in the Civil War and American history. Bud Robertson grew up poor in Danville, Virginia dreaming of becoming a railroad engineer. But fate intervened and he was encouraged to go to Randolph-Macon College and earned his bachelor's degree in history followed by his master's and doctorate which he earned under the tutelage of famed historian Bell Wiley at Emory University. He would spend 44 years teaching at Virginia Tech beginning in 1967 where he taught over 25,000 students in his popular course on the Civil War! He authored and edited 40 books on the Civil War and his biography on Stonewall Jackson will forever be the definitive work on Jackson. In 1962 during the 100th anniversary of the Civil War, President Kennedy called on the then 32-year-old Robertson to be the Executive Director of the Centennial Commission which he admirably led through some tumultuous times bringing together 34 state committees to work to commemorate the war. When Kennedy was assassinated on November 22, 1963, Jackeline Kennedy asked Bud to help plan Kennedy's funeral as she wanted it to be as much like Lincoln's as possible. Bud's accomplishments are too many to list here but here are a few of them. He was an ACC college football referee for 13 years and was later elected to the Virginia Tech Athletic Hall of Fame because of his many contribution to the Tech athletic program. He played drums in a swing band and worked in a mortuary to provide money for his wife and children while he was working on his PhD at Emory. He was the lead historical consultant on the movie "Gods and Generals". But we of the Louisville Civil War Round Table will remember Bud as a true friend and as a dynamic and spell binding speaker. He had spoken at our Round Table over 40 times beginning in the 1960's and always looked forward

to coming to Kentucky. He loved to tell about the great times he had with our founder, Frank Rankin and the infamous cruise on the Bell of Louisville that ended with all the cars parked on Shawnee golf course being mired in mud. He spoke at our 40th anniversary and our 50th anniversary and over the years became the most popular speaker we have ever had. Bud will be greatly missed by our Round Table and by all the Civil War community. William C. "Jack" Davis said, "For fully six decades Bud Robertson was a dominant figure in his field, and a great encouragement to all who would study our turbulent past during the middle of the 19th century. Moreover, amid a conversation that can still become bitter and confrontational, his was a voice for reason, patience, and understanding. In the offing, he has become virtually 'Mr. Virginia,' a spokesperson for the commonwealth past, present, and future. His voice is now sorely missed — and irreplaceable."

2020 Spring Field Trip: 1865 Carolinas Campaign

Signups Are Underway!

Next year's field trip will be to North Carolina where we will study the 1865 Carolinas Campaign. This trip is one we have never done before. The dates for the trip are April 1-5, 2020 and our guide will be Wade Sokolosky. Wade is a retired Colonel and a 25-year veteran of the U.S. Army. He is a leading expert on the 1865 Carolinas Campaign and has led many tours of these historic sites. We will be headquartered in Smithfield, N.C. which is about 30 miles south of Raleigh. From our headquarters in Smithfield we will visit all the major battlefield and historic sites of the 1865 campaign including the battlefields of Wise's Forks, Monroe's Crossroads, Averagesboro, and Bentonville. We will also visit several other historic sites and museums in the area including a visit to the C.S.S. Neuse at the Ironclad State Historic Site. There the remains of the Neuse are preserved and there is a full-scale replica of the Neuse. Our Guide, Wade Sokolosky, in addition to leading battlefield tours, has lectured widely on the Carolinas Campaign at historic organizations and roundtables and has co-authored with Mike Smith "No such Army Since the Days of Julius Caesar: Sherman's Carolinas Campaign". He is the author of "Final Roll Call: Confederate Losses in the 1865 Carolinas Campaign". Wade's latest book, also co-authored with Mike Smith, "To Prepare for Sherman's Coming: The Battle of Wise's Forks, March 1865". We are very fortunate to have Wade as our guide and we are looking forward to another great field trip. Mark your calendars for April 1-5, 2020. **The signup sheet will be at the December meeting. Mrs. Lincoln refused to yield possession of the White House, where the office was located, and Johnson refused to rush her out. She finally left on May 22, 1865.
